As the dust continues to settle from Election Day, all eyes are on Governor-elect Greitens as he continues to put his transition team in place. And while many familiar names have been rumored to be on the short list for cabinet positions, no official announcements have been made.

One thing that is for certain, is that Republicans now have an opportunity to push through their legislative agenda since they control both chambers of the General Assembly as well as the Governor's office.

At the top of that agenda is Right to Work legislation, which has been met with current Governor Nixon's veto pen the last few years. Now, with Greitens taking the helm in January, it appears enactment of the measure is a sure thing. Speaker of the House Todd Richardson, Senate President Pro-Tem Ron Richard, and Greitens have all publicly stated Right to Work is a high priority.

Other labor related items affecting the construction industry include prevailing wage. Many efforts were put forth last year, primarily in the House of Representatives, to exempt certain projects like schools from prevailing wage requirements, and there were also measures to eliminate prevailing wage in its entirety. This is an issue certain to garner much attention and lengthy debates. We have heard no public comments from Governor-elect Greitens regarding his position on prevailing wage.

Another major issue facing legislators continues to be highway and transportation funding. It appears Senator Doug Libla will once again try to advance an increase in fuel taxes to help with the funding shortfall. This is another area where we are unsure of Greisens' position.

It also remains to be seen how the passage of Constitutional Amendment 2 will impact campaigns going forward. The language passed by voters in November places limits on the dollar amount a candidate for office may accept from an individual, business, labor union or PAC account. Over the past several years, we have seen major donations from certain individuals going to many candidates, with some reaching the million-dollar mark. The new law will go into effect after the Secretary of State certifies the election results, which will likely be in early December.

Pre-filing of bills for the 2017 legislative session began December 1. We will monitor the bills being filed along with other activity at the Capitol that may have an impact on the construction industry as things begin to ramp up ahead of the start of the 2017 legislative session that begins Wednesday, January 4. The inauguration will be on January 9th. With the change in administration, we expect session will get off to a slower start this year than the past several years.

Submit Your Electronic Entry for ASA's Excellence in Ethics Awards by Dec. 16

Entries for ASA's Excellence in Ethics Awards will be accepted electronically through Dec. 16, 2016, but the required sealed letters of recommendation still must be submitted by mail by then. Subcontractors that are committed to professionalism and sound business practices are encouraged to apply.

ASA provides a timeline and resource guide to help applicants meet a number of critical milestones that must be met leading up to the deadline. The timeline and resource guide can be particularly useful for those subcontractors who not developed have vet а formal ethics program and policy. The guide, for example, contains model documents, such as sample recommendation letter requests and model policies on topics ranging from competition and conflicts of interest to internal procedures and whistle blowing.

Each applicant is required to respond to questions concerning the firm's corporate ethics policies and procedures, its construction practices, and its general business practices. Each applicant also is required to submit detailed documentation, including sealed letters of recommendation from a customer, a competitor, and a supplier.

ASA will present the 2016 Excellence in Ethics Awards during SUBExcel 2017, which will take place March 15-18, 2017, in Denver, Colo.

Illinois Court Rules Against Subcontractor Mechanic's Lien Rights

The Appellate Court of Illinois, Second Judicial District, issued a decision, on Nov. 9, affirming the summary dismissal of a subcontractor's mechanic's lien claim of a subcontractor, in the case of AUI Construction Group, LLC, vs. Louis J. Vaessen, et al.

The Appellate Court held that a subcontractor owed in excess of \$3.5 million for unpaid work building on a 500-foot-tall wind power plant, with a foundation 12 feet below ground was removable and not an improvement to real property giving rise to mechanic's lien rights principally due to the fact that an easement agreement (which was not recorded until more than \$1.7 million in unpaid work had been performed) between the property owner and project developer provided that the wind tower was to be removed upon termination of a 50-year easement. ASA's Subcontractors Legal Defense Fund filed a "friend of the court" brief in support of the unpaid subcontractor in this case.

Eric Travers, a partner with the Columbus, Ohio, law firm of Kegler, Brown, Hill and Ritter, ASA's general counsel, called the decision "discouraging" and "at odds with the public policy of the Illinois Mechanic's Lien Act," noting that the rationale used by the court could "deprive untold numbers of subcontractors and suppliers on future project of mechanic's lien rights the Illinois legislature granted."

Who needs to be certified or qualified? Any person engaged in a construction activity who is operating a crane covered by the new cranes and derricks rule, except: side boom cranes, derricks, equipment with a rated hoisting/lifting capacity of 2,000 pounds or less. (Operators of the listed equipment must meet the criteria for minimum expertise described elsewhere in OSHA rules.)

Are operators of digger derricks required to be qualified or certified? Yes, unless the digger derrick is being used auger holes for poles to carrying electric or telecommunication lines, place or remove the poles, or handle associated materials to be installed on or removed from the poles.

What is required in the testing for certification? Certification has two parts: (1) A written examination that includes the safe operating procedures for the particular type of equipment the applicant will be operating and technical understanding of the subject matter criteria required in the rules; (2) A practical exam showing the applicant has the skills needed to safely operate the equipment, including, among other skills, the ability to properly use load chart information and recognize items required in the shift inspection.

Licensing by a state or local government (if that licensing meets the minimum requirements set forth by OSHA). When a state or local government requires a crane operator license, the crane operator must be licensed accordingly to meet OSHA requirements.
