SUB LEFT HOLDING EMPTY BAG: NO LIEN, NO BOND CLAIM, **BIG PROBLEM**

Subcontractors are accustomed to believing their payments are secured by either a mechanic's lien or a payment bond, sometimes both. For example, when the public utility, its quasi-governmental status, it should be immune from mechanic's liens, the Court went on to say that AmerenUE bond when one is required. would be required to have its prime contractors post payment bonds for the protection of subcontractors.

By requiring a payment bond as a substitute for a mechanic's there would appear to be a seamless continuum built into the payment process for the protection of a cloud over this notion.

In this case, St. Louis County owned property it planned to develop for the headquarters of Smurfit-Stone Container Enterprises. The fact that the County owned the property was critical in the Court's view even though the property was purely private in nature without any governmental function. The County was to issue industrial revenue bonds to finance the project, upon which only Cornerstone VI, LLC, the tenant, could draw. The County and Cornerstone had a contract requiring Cornerstone to construct the project "on behalf of the County" and it authorized Cornerstone to act "as agent of the would have had to obtain a bond. County."

subcontract with Pal's Glass to supply the glass and glazing scope of work. In turn, Pal's entered into a sub-subcontract with Brentwood Glass for some of the work. Brentwood Glass served notice of its intent to file a mechanic's lien. Thereafter, because it was still not paid it filed its mechanic's lien against the County's ownership interest in the real estate and also against Cornerstone's leasehold interest. While the Court said Brentwood Glass could place a lien against Cornerstone's leasehold interest, it could not place a lien against the more valuable asset, namely, St. Louis County's ownership interest in the real estate.

The Court's decision is noteworthy not only because of the result, but also because of its lack of analysis. In its written opinion the Court cited to the general rule that liens against property owned by the government are not allowed, but it failed to discuss or analyze the well-known exception allowing liens on property owned by the government and used for nongovernmental purposes. Until the Supreme Court's decision it has been generally understood that mere ownership of real estate by a Missouri governmental body will not by itself preclude liens against the property if the property is not used for public purposes.

A 1991 decision of the Missouri Court of Appeals said, "Only such property held by [the government] for the benefit of the public which can be determined to be reasonably necessary for public use is exempt." While the Supreme Court's decision in the Brentwood Glass case recites that the building was to be used "for the headquarters of Smurfit-Stone Container Enterprises, Inc.," the court inexplicably failed to mention or discuss this well-known exception to the general rule of "no lien against government owned property." Using the property as a corporate headquarters for a private entity can hardly be viewed as a public purpose.

No doubt believing that it was protected by either a lien or a payment bond. Brentwood Glass also made a claim in its lawsuit against St. Louis County attempting to hold the County liable for failing to obtain a payment bond for the benefit of unpaid subcontractors. There is an established body of case AmerenUE, convinced the Missouri Court of Appeals that due to law in Missouri permitting such actions against the governmental employees/officials who fail in their duty to obtain a payment

In the Brentwood Glass case five of the seven judges on the Supreme Court said no bond was required because "Cornerstone did not 'provide construction services' under its contract with the County...." The Court again was skimpy on analysis. The Court merely noted the statute "requires a bond of a 'contractor' that 'provides construction services under contract subcontractors. However, the Missouri Supreme Court has cast to a public entity, not a party that merely arranges for such services to be provided by others."

> It is regretful that the Court failed to provide any analysis. If it had done so, it may have reached a different The Court based its decision on its belief that Cornerstone, the developer who had a contract with the County to construct the property, did not "provide" construction services to the County. No bond was required apparently because Cornerstone did not self-perform work, but merely hired others to do so. The Court recognized Cornerstone as the "agent" of the County but did not find it had the responsibility the County

An analysis of prior case law would show in the Clayco, Inc., the general contractor, entered into a context of construction law that a party may be deemed to "provide" services even if those services are to be performed by others, such as subcontractors. For example, in Strain-Japan R -16 School District v. Landmark Systems, Inc., the Court said that a contract to "provide" engineering services should not be confused with a contract to "render" those services. In other words, if a general contractor enters into a design-build contract and uses a professional engineer as a subconsultant for the design, the general contractor is deemed to have "provided" the engineering services even if they are rendered by a licensed professional engineer and not the unlicensed contractor. Using this precedent and interpretation, Cornerstone could have been deemed to be "providing" construction services and thus obligated to obtain a payment bond for the protection of Unfortunately, the Court's decision could subcontractors. mean that in the future a contractor hired by a governmental body to serve as its construction manager may not have to obtain bond protection for subcontractors if that construction manager does not self-perform any of the work.

> This case cries out for legislative relief. Until that happens beware of the added risk when working on projects in Missouri where the property is owned by a governmental body, used for a private or non-public purpose and financed through industrial revenue bonds.

Since the programs inception, a total of 2,262 tickets, valued at over \$178,000, have been donated to our men and women in the armed services, so that they can attend a baseball game with their families!

The month of July was relatively quiet on the legislative front. As of newsletter press time, the General Assembly was still in the midst of a second special session considering legislation dealing with abortion. The Governor has taken on the bill passed by the General Assembly as the constitutional deadline for bills to either be signed or vetoed was July 14.

Senate President Pro-Tem Ron Richard has established the Senate Interim Committee on Labor Reform. The stated mission of the committee is "to conduct in-depth studies and make appropriate recommendations concerning the hourly rate of wages to be paid to workers by or on behalf of any public body engaged in public work and the regulation of public-sector labor organizations and public bodies that deal with such organizations". Committee members include Senators Dave Schatz, Dan Brown, Jacob Hummel, Brian Munzlinger, Bob Onder, Ryan Silvey, and Gina Walsh. A meeting date for the committee has not yet been scheduled. However, ASA along with other construction trade groups have been meeting all summer with groups who favor total repeal or a modification of prevailing wage to try to come up with a solution both sides can live with on the issue.

July 14 marked the constitutional deadline for the Governor to either sign, veto or take no action (which simply means a bill becomes law without the Governor's signature). Out of the 59 policy bills and 16 appropriation bills, the Governor only vetoed 5 bills. Worth noting, the Governor allowed HB1194 to become law without his signature. The bill prohibits political subdivisions from requiring a minimum wage that exceeds the requirements of state law. This bill was filed and passed to address a local St. Louis ordinance that would have raised minimum wage rates above what is allow by the State of Missouri. Also, worth noting SB16 was signed into law by the Governor. The bill that didn't get much attention during the legislative session. The bill exempts delivery charges from sales and use tax. All bills, unless they contained an emergency clause, will go into effect on August 28, 2017.

As reported in the July newsletter, Governor Eric Greitens called a second special session on June 12 to deal with abortion laws in the state. The bill started in the Senate and was taken up and passed in a significantly different version by the House the following week. Since the House version was different than the Senate version, the Senate must take the bill back up. While the bill sat idle, the Governor amended his call for special session to specifically cater to the bill passed by the House. It appears a conference to hash out the difference in the two versions is not likely and, based on the Governor's revised special session call, the Senate likely will take up the bill as passed by the House. The issue sat idle the second half of June and most of July; however, the Senate was scheduled to take the bill up again the week of July 24. As of newsletter press time, there we did not know the outcome of this bill.

The 21st Century Missouri Transportation System Task Force held their first meeting in Jefferson City on June 28, where they heard a presentation from MoDOT Director Patrick McKenna. There were varying opinions from committee members and from those who testified, regarding funding solutions for the state's aging infrastructure. Topics discussed included a motor fuel tax increase, better utilizing current revenue sources, and the possibility of public-private partnerships and tolling. The committee is slated to meet again on July 26 in Kansas City in the Union Station Board Room.

Governor Eric Greitens recently signed Executive Order 17-18, which creates a prescription drug monitoring program (PDMP), for the state. The General Assembly has debated the establishing a PDMP for years, but has not been able to pass such a bill because some members think creation of another government database equals too much overreach into citizens' private lives. Until now, Missouri was the only state in the nation without such a monitoring system. Some have applauded the governor's order saying it is one of the steps necessary in battling the current opioid epidemic. Others, meanwhile, say the governor is acting in the manner of a dictator by issuing executive orders, and bypassing the legislative process.

ASA's annual "National Construction Best Practices Awards," developed by the Task Force on Ethics in the Construction Industry, recognize elite prime contractors that uphold best practices and refuse to do business according to the "lowest common denominator." The deadline for prime contractors to submit applications is Nov. 3, 2017. The application fee is S495. Each prime-contractor applicant must supply three sealed business-practices recommendations from specialty trade contractors that have worked for it in the past year, along with a copy of its standard subcontract, with its application. ASA will honor recipients during an awards ceremony at the ASA annual convention, SUBExcel 2018, Feb. 28-March 3, 2018, in Tempe, Arizona.

OSHA Silica Rule Compliance Date Less than Two Months Away

Construction contractors with more than 10 employees have just two months to comply with OSHA's final rule regulating employee exposure to respirable crystalline silica. Under a rule issued by OSHA on March 25, 2016, construction employers must comply with all requirements of the standard by Sept. 23, 2017, except requirements for laboratory evaluation of exposure samples, which begin on June 23, 2018. The rule requires construction employers to limit worker exposure to silica and to take other steps to protect workers.

Crystalline silica is a common mineral found in many naturally occurring materials and used at construction sites. Inhaling very small crystalline silica particles can cause multiple diseases, including silicosis, lung cancer, chronic obstructive pulmonary disease and kidney disease. Respirable silica is generated by high-energy operations like cutting, sawing, grinding, drilling and crushing stone, rock, concrete, brick, block and mortar. Activities such as abrasive blasting with sand; sawing brick or concrete; sanding or drilling into concrete walls; grinding mortar; and cutting or crushing stone generate respirable dust.

Under the OSHA standard, construction employers can either use a control method, as laid out in Table 1 of the standard, or they can measure workers' exposure to silica and independently decide which dust controls work best to limit exposures to the permissible exposure limit in their workplaces.



Regardless of which exposure control method is used, all construction employers covered by the standard are required to:

- Reduce the permissible exposure limit for respirable silica to 50 micrograms per cubic meter of air, averaged over an eight-hour shift.
- Use engineering controls, such as water or ventilation, to limit worker exposure to the PEL.
- Provide respirators when engineering controls cannot adequately limit exposure.
- Establish and implement a written exposure control plan that identifies tasks that involve exposure and methods used to protect workers, including procedures to restrict access to work areas where high exposures may occur.
- Designate a competent person to implement the written exposure control plan.
- Restrict housekeeping practices that expose workers to silica where feasible alternatives are available.
- Offer medical exams, including chest X-rays and lung function tests, every three years for workers who are required by the standard to wear a respirator for 30 or more days per year.
- Train workers on work operations that result in silica exposure and ways to limit exposure.
- Keep records of workers' silica exposure and medical exams.

ASA, in collaboration with 22 other construction associations, has initiated a lawsuit to prevent OSHA from implementing its rule. In addition, ASA, as part of the Construction Industry Safety Coalition, has filed a petition with OSHA requesting the agency to stay and reopen the rulemaking.

In the meantime, ASA urges construction employers to take steps to be in compliance by the OSHA deadline.
