On October 7th ASAMWC held its annual strategic planning session. This session was attended by the current Board of Directors, Officers, Past Presidents and the various Committee Chairpersons. One of the hot safety topics that was discussed during this session, is the new OSHA Respirable Crystalline Silica Standard (1926.1153), that has started to be enforced (effective September 23, 2017).

Most of us in the construction world have been anticipating this update to the silica exposure limits, but is everyone in compliance or have you been dragging your feet. We'll the good news is that it sounds like OSHA realizes that this new Standard is going to change the way some companies do business and that they might need a little adjustment period. The bad news this adjustment period is only 30 days. According to an OSHA memorandum dated September 20th "During the first 30 days of enforcement, OSHA will carefully evaluate good faith efforts taken by employers in their attempts to meet the new construction silica standard. OSHA will render compliance assistance and outreach to assure that covered employers are fully and properly complying with its requirements. Given the novelty of the Table 1 approach, OSHA will pay attention to assisting employers in fully and properly implementing the controls in the table. OSHA will assist employers who are making good faith efforts to meet the new requirements to assure understanding and compliance."

One good faith effort that I would suggest for getting started, which is also an OSHA requirement, is to make sure all workers receive some sort of performance - based silica awareness training. This training should "ensure that each employee covered . . . can demonstrate knowledge and understanding of at least the following":

- ✦ "The health hazards associated with exposure to respirable crystalline silica"
- ✦ "Specific tasks in the workplace that could result in exposure to respirable crystalline silica"
- ✦ "Specific measures the employer has implemented to protect employees from exposure to respirable crystalline silica, including engineering controls, work practices, and respirators to be used"
- ✦ "The purpose and a description of the medical surveillance program" intended to monitor workers for exposure to silica
- ✦ The section of the rule immediately pertaining to either maritime and general industry workers, or to construction industry workers
- ✦ Anything else you believe employees should be trained on in relation to respirable crystalline silica in your workplace
- ✦ Can identify the designated job site competent person


The year isn't three fourths complete yet, and to date our local construction industry has been impacted by several significant issues including increased cyber security threats, right to work and related laws, change order and payment problems at the mammoth BJC project, and labor shortages. All of these directly or indirectly impacted the financial performance of our local construction companies. Yet in spite of both old and new issues and challenges, for the most part it's been another good year.

The pundits vary some on nationwide expectations for 2018, which will be impacted on what, if anything the president and congress can agree on, and if and when the Federal Reserve increases interest rates meaningfully. I think it is safe to consider that both are gray areas at best. The most current AIA Consensus Forecast projects (nationally) 3.5 to 4.0 percent growth for the balance of 2017 and 2018. Two components of note, Dodge Data & Analytics and FMI are much more bullish at 5 to 5.5 percent!

Locally, the Federal Reserve Bank provides data regarding Total Nonresidential Construction Spending, a very broad category but a quick glance at the 15 year chart puts interesting perspective on our current situation.

The Architectural Billing Index (ABI) a well know 'leading indicator' for construction activity in nonresidential buildings. Generally, the Midwest lags the indicator by about 9 months. So theoretically, the ABI could give you about a 9 to 12 month 'heads up' on significant up or downturns in construction activity. The ABI for August was published on September 20, just a few days before this publication date. The overall index was 53.7, and the Midwest region (which includes Missouri and Illinois) index was 52.5. A score above 50 indicates an increase in architectural billings from the month before. Accordingly, the August billings were greater than the July billings. That is seven consecutive months of increases for the overall index.

Considering all of this data, it's conservative and reasonable to project at least flat to limited growth for the balance of 2017 and 2018 for the construction industry as a whole. So, at least at this point, it seems this aging bull market for construction still has some life left in it.



This graph does not give any indication about what 2018 will bring, but it does indicate the nonresidential spending appears to have topped out in 2015 – 2017 at about the same levels as the 2008 – 2009 “boom” years.

September brought the General Assembly back to Jefferson City, as the constitutionally mandated veto session was held on September 13.

There very little was little action as far as attempts to override any vetoes issued by the Governor, as only one override motion was made in the House and none in the Senate. At issue was HCB3, a measure vetoed by Governor Greitens that would have provided necessary funding to senior citizens receiving skilled nursing care and in-home services.

The override attempt failed, leaving a question mark on how to fund those services. House and Senate leadership both stated they are committed to finding a solution, but did not provide details on their plans. The lack of funding could have a serious impact on any new construction or renovations of existing structures needed to care for the senior citizen population.

Other items of interest at veto session included the ongoing controversy with Senator Maria Chappelle-Nadal and also Representative Warren Love. Chappelle-Nadal had been urged to resign her position after she made comments on social media hoping for the assassination of President Trump. Many Senators had said they would vote to remove her from office if she failed to resign, but in the end, there were not enough votes to expel her, so the Senate instead voted for censure.

Representative Love made a social media gaffe as well, stating that those responsible for defacing a confederate memorial in Springfield should be “hung from a tall tree with a long rope”. The House of Representatives voted to have the House Ethics Committee investigate the incident.

The Senate Interim Committee on Labor Reform held a hearing at the conclusion of veto session. The hearing focused primarily legislation that had been filed in the 2016 session, such as the paycheck protection issue, annual union recertification and open negotiations with public employee sector unions. Senator Bob Onder provided the bulk of the testimony calling for public union reforms, with Americans for Prosperity, Show-Me Institute, Representative Justin Hill, The Bell Weather Institute and former Senator Jane Cunningham all offering supporting testimony for Onder’s position. The SEIU and the NEA offered opposing testimony. There was no discussion of prevailing wage issues.

Finally, the 21st Century Missouri Transportation System Task Force is scheduled to meet on Wednesday, September 20, at the Student Union Building on the campus of Truman State University in Kirksville. Items listed on the agenda for discussion modern technology as it relates to transportation.

OSHA's Top Ten Violations

This is OSHA's list of the 10 most frequently cited safety and health violations for 2016 compiled from nearly 32,000 inspections of workplaces by federal OSHA staff. More than 4,500 workers are killed on the job every year, and approximately 3 million are injured.

One remarkable thing about the list is that it rarely changes. If all employers simply corrected the top 10 hazards, I am confident the number of deaths, amputations and hospitalizations would drastically decline.

Consider this list a starting point for workplace safety.

As business owners you have to ask yourself are you doing everything possible not to be on this list?

1. Fall protection
2. Hazard communication
3. Scaffolds
4. Respiratory protection
5. Lockout/Tagout
6. Powered industrial trucks
7. Ladders
8. Machine guarding
9. Electrical wiring
10. Electrical, general requirements

OSHA Announces Policy for Enforcing Silica Rule Beginning Sept. 23

The Occupational Safety and Health Administration announced that from Sept. 23 through Oct. 22, it will help employers who are trying to comply with its rule on respirable crystalline silica, which requires construction employers to limit worker exposure to silica and to take other steps to protect workers. During that 30-day period, all citations under the rule will be reviewed by OSHA at the national level. The memorandum from Thomas Galassi, acting deputy assistant secretary for the U.S. Department of Labor, to OSHA regional administrators, states:

"During the first 30 days of enforcement, OSHA will render compliance assistance and outreach to assure that covered employers are fully and properly complying with its requirements. Given the novelty of the Table 1 approach, OSHA will pay particular attention to assisting employers in fully and properly implementing the controls in the table. OSHA will assist employers who are making good faith efforts to meet the new requirements to assure understanding and compliance."

"If, upon inspection, it appears an employer is not making any efforts to comply, OSHA's inspection will not only include collection of exposure air monitoring performed in accordance with Agency procedures, but those employers may also be considered for citation. Any proposed citations related to inspections conducted in this time period will require National Office review."

Under the OSHA standard, construction employers can either use a control method, as laid out in Table 1 of the standard, or they can measure workers' exposure to silica and independently decide which dust controls work best to limit exposures to the permissible exposure limit in their workplaces. Regardless of which exposure control method is used, all construction employers covered by the standard are required to:

- Reduce the permissible exposure limit for respirable silica to 50 micrograms per cubic meter of air, averaged over an eight-hour shift.
- Use engineering controls, such as water or ventilation, to limit worker exposure to the PEL.
- Provide respirators when engineering controls cannot adequately limit exposure.
- Establish and implement a written exposure control plan that identifies tasks that involve exposure and methods used to protect workers, including procedures to restrict access to work areas where high exposures may occur.
- Designate a competent person to implement the written exposure control plan.
- Restrict housekeeping practices that expose workers to silica where feasible alternatives are available.
- Offer medical exams, including chest x-rays and lung function tests, every three years for workers who are required by the standard to wear a respirator for 30 or more days per year.
- Train workers on work operations that result in silica exposure and ways to limit exposure.
