

## Is it time to consider a **VoIP phone system?**

Barry Herring CMIT Solutions

There are always four questions that come up when people learn we help companies switch their telephone service to a Voice over Internet Protocol (VoIP) solution:

- 1. What is VoIP?
- 2. How does it work?
- 3. Is it cheaper than what I am paying now?
- 4. Is it better than what I have now?

We could spend an hour on each of these questions, but I will try to keep it as brief as possible. Here are the typically four types of phones system you will find in business today:

- 1. Traditional Multi-Line analog systems
- 2. Hybrid VoIP and Traditional Analog systems
- 3. VoIP
- 4 Cell Phones

Each in their own way have both pros and cons and depending on how each of them are being used, will out shine its competitors; if they did not, they would not have a place in the market share.

We have been using VoIP in our business for over 7 years now. During that time period we have had very few issues. Most issues, generally an Internet Service Provider (ISP) outage, were out of our control. Since VoIP uses the internet to carry voice traffic, this is a crucial element to the system. Just a quick note here, in a traditional phone system you are dependent on the Phone Company being able to deliver your voice traffic. With VoIP there are multiple less expensive ways to reduce the risk of your phones being down.

So why do we use VoIP, there are many reasons. First and foremost, we have the ability to configure the way it works for what we need it to do for our company. It is easy to use, easy to configure, easy to add and remove phones, adjust auto attendant, call flows, one Private Branch Exchange (PBX) for company with multiple 2 locations.

offices in St. Louis and Chicago and both locations are any question, now might be the time to investigate VoIP. controlled from a central location in St. Louis.

They have the ability and freedom to open an office anywhere in the continental United States and put that new location under the same phone system with the ability to transfer calls between location by dialing phone extensions.

We worked with them to do a cost comparison between two individual Traditional Analog systems and the cost to upgrade their existing network infrastructure, while moving to VoIP. Their Return on Investment (ROI) was 16 months. They are currently on month 9 and very happy with the new phone system and its abilities to handle their needs at both locations. Their internal Office Manager can configure and make changes as needed. Without the need to rely on another company to make changes for them.

When we are asked to do a cost comparison between Traditional Analog systems and VoIP. Cost alone for VoIP is generally cheaper (This depends on the VoIP company you are looking at.). But what you need to understand is voice traffic is now going over your Internal Network Infrastructure. If that equipment is not able to distinguish between data and voice traffic, you may experience some voice quality issues. With the correct equipment in place, your voice traffic can be given priority over your data traffic. This does not imply that your network speed will be affected, but does imply, how it handles data on and off your network.

Another area that VoIP has helped our company is with technician's cell phone numbers being given out. The technicians are on the road or at a client location. With our VoIP vendor they have developed an application for cell phones. When making a business call for our company, the technicians will call out through the application. The caller on the receiving end of this call sees the company phone number coming in, not the technicians personal cell number. Calls from customers can be transferred, routed to the technician's cell easily without call interruption. Technicians like that their cell number is not in the client's phone, eliminating direct calls to them after hours.

I will leave you with some questions you need to ask yourself if you have every thought about switching to VoIP:

- Does my current system meet our needs?
- Will it grow with us?
- 3. Is it easy to use?

The 2018 General Election is behind us and legislators are preparing for the start of the 2019 Legislative Session. Bill pre-filing begins December 1, 2018. The 2019 legislative session begins January 9, 2019. Election Day results brought about a few surprises, but none were more disappointing than the defeat of Prop D, which would have raised fuel taxes to generate necessary revenue for road and bridge improvements across the state. The final vote count showed that voters rejected the proposal with 46.4% in favor and 53.6% opposed.

The measure had been pushed hard by Governor Mike Parson, Lt. Governor Mike Kehoe, MoDOT Director Patrick McKenna, and a host of statewide organizations and associations. The looming question now is how will MoDOT proceed with desperately needed projects with a very limited funding source. Legislative leaders have already begun to explore their options, with talks of increasing vehicle registration fees or a slight fuel tax increase that stays below the Hancock threshold but there are no easy answers on the horizon at this point. These measures would only provide a fraction of the revenue needed to fund new projects. Sixty-two percent of voters agreed to raise the minimum wage in the state. Prop B passed easily and will mandate that by the year 2023, the minimum wage will be \$12 per hour.

Voters also approved the legalization of medical marijuana, more relaxed laws on bingo games, and a proposal that will modify lobbying laws in the state, cap campaign contributions, and prescribe a new method for drawing legislative district lines.

Other election returns showed that Republicans will retain their supermajority in both chambers, with a 116 -47 advantage in the House and a 24-10 margin in the Senate. There will be many new faces in the Capitol when session resumes, with 60 new members in the House and 9 in the upper chamber.

New leadership will also take the reigns in the General Assembly in the coming session. Senator Dave Schatz of Franklin County was elected by his colleagues as the new President Pro-Tem, with Senator Caleb Rowden being chosen to serve as the new Majority Floor Leader. Rowden represents Boone and Cooper Counties. The House of Representatives will see Elijah Haahr of Springfield take over as the new Speaker. Rob Vescovo of Arnold will remain as the Floor Leader.

With Josh Hawley winning the US Senate race against long time incumbent Claire McCaskill, a vacancy was created in the office of Attorney General. On November 13, Governor Parson announced that current State Treasurer Eric Schmitt would be tapped to fill the remainder of Hawley's term. Schmitt is a former partner in the Lathrop-Gage law firm, served eight years as a state senator representing St. Louis County, and was elected as Treasurer in 2016. Parson must now make an appointment to fill the vacant Treasurer's spot. This means that of the six statewide elected officials, Parson will have appointed three.

Pre-filing of legislation for the 2019 legislative session begins on December 1. As always, we will monitor any legislation and events in Jefferson City that may impact ASA and the construction industry.

PRESERVE RIGHT TO SUSPEND WORK IF NOT

The safety incentive programs and/or conduct post-incident you drug testing do so to promote workplace safety and health. Action taken under a ... postincident drug testing policy would only violate 29 C.F.R. § 1904.35(b)(1)(iv) if the employer took the action to penalize an employee for reporting a work-related injury or illness rather than for the legitimate purpose of promoting workplace safety and health.

- Random drug testing.
- Drug testing unrelated to the reporting of a workrelated injury or illness.
- Drug testing under a state workers' compensation law.
- Drug testing under other federal law, such as a U.S. Department of Transportation rule.
- Drug testing to evaluate the root cause of a workplace incident that harmed or could have harmed employees. If the employer chooses to use drug testing to investigate the incident, the employer should test all employees whose conduct could have contributed to the incident, not just employees who reported injuries.

# Changes Coming SOON! Branden Bell United Rentals

Did you know that there are some significant changes coming to standards covering Aerial Lifts? When exactly we still don't know. It's been in the works for some time and is expected to be finalized this year

ANSI A92: A Guide to the Aerial Lift Standards Coming Soon Equipment, training and operation will all be affected. Changes are coming to aerial lifts — now to be called Mobile Elevating Work Platforms (MEWPs) — and the American National Standards Institute (ANSI) standards that dictate their design and usage.

**ANSI A92**, developed by a standards committee after almost two years of work, addresses the design of new aerial lift equipment as well as the type of training operators, supervisors and maintenance personnel must receive.

#### **New classifications**

One big change made in ANSI A92 is the way aerial lifts are classified. All will be referred to as Mobile Elevating Work Platforms (MEWPs), and there will be two classes:

**Group A.** In these, the center of the work platform remains within the perimeter of the chassis at all times. Examples include scissor lifts and vertical lifts.

**Group B.** In these, the center of the work platform can be positioned beyond the chassis. Boom lifts fall into Group B.

#### Each group is further broken down into:

**Type 1**, which can travel only in the stowed position and must be moved manually

**Type 2**, which are controlled from the chassis and can be driven elevated

**Type 3,** which have controls on the work platform and can be driven elevated.

ANSI and CSA are trying to get their standards more global, so they are beginning to use the same terminology that has been used abroad.

#### **Equipment changes**

Under ANSI A92, new aerial lifts will be required to have sensors that sound an alarm and prevent the machine from operating when the safe load limit is exceeded. The machinery must also include a tilt sensor that triggers an alarm and prevents movement of the chassis or work platform when a certain level of slope is exceeded.

Chains to close off entrances to the work platform will no longer be permitted; MEWPs will have to have a gate, complete with toe guards.

ANSI A92 will require MEWPS used outdoors to have sensors for wind speed so load capacities can be reduced in windy conditions. MEWPs labeled for indoor use only won't require these sensors.

The required height for the equipment platform railings will be raised to 43.5 inches, up from 39 inches.

To improve stability, MEWPs used on rough terrain will need solid tires or foam-filled tires rather than air-filled tires.

Even though nothing has been officially approved at this point, most manufacturers are already implementing these changes. Most of the new equipment that United Rentals is receiving already has most if not all of the new requirement components.

#### Safe operation and training

ANSI A92 will set new training requirements.

For example, the people who maintain the MEWPs will have to receive training on the new features, like the tilt and load sensors. Supervisors on the ground who are in charge of the lift crews will also have to receive specific training, which wasn't previously required.

In addition, if you as an operator have somebody who is going up in the boom lift with you, it's now your responsibility to explain to that individual the basics of what they should do if something happens to you — how they can get you both back down. There must also be a dedicated person on site who knows how to operate the equipment from the ground if the occupants in the platform are unable to lower themselves

ANSI A92 also requires a site- and equipment-specific rescue plan. Although that's always been needed, until this revision it has not been spelled out in ANSI. So folks are going to have to be thinking about and creating a documented rescue plan in case an operator is elevated in a 60-foot boom lift and it no longer functions. What do they do? How would they be rescued?

Another new requirement: Operators must familiarize themselves with the operation of each MEWP. In the past, an operator familiar with one type of lift would need to receive instruction from a qualified person on another lift's operation before operating it. Under ANSI A92, operators will be responsible for reading the operator's manual, walking around the equipment and familiarizing themselves with it.

All of these changes will require companies to update their training for anyone who operates, supervises or maintains MEWPs.

#### Timetable and challenges

The aerial lift industry has been anticipating the release of ANSI A92 since early 2018, but due to requests for clarifications filed during the comment period, there is no firm release date yet. Once the standards are released, companies will have 12 months to comply. Once that year has passed, manufacturers will have to include all of the new required features, but older equipment that doesn't meet the new standards will not need to be retrofitted, and companies can continue to use it.
