November 14 Monthly Business Meeting Soccer Park-Fenton While reviewing construction revenues across the country, one thing certainly jumped out at me, we rank far off the pace in the St. Louis market. We can all make the excuses that we typically lag into and then out of recessionary economic climates, but I think all of us can look further under the covers to some realities.

We have a lot of positives in our city, low utility costs, quality water and endless supply, quality workforce, reasonable housing costs, very good schools, superior healthcare facilities, professional sports franchises and tremendous restaurants, etc. Why wouldn't companies want to build in St Louis?

My first question would be why have so many companies left to begin with? It would appear that we do not do ourselves any favors politically. The national recognition of our crime rates do not help our cause either as that is all people outside the area hear, they do not know that the city and county are separate and if combined they would likely never hear about crime statistics for our area.

Our once vibrant construction market has slowed to the point where many general contractors and subcontractors have gone out of business while others are evaluating how to stay in business. Critics would say we priced ourselves out of the market while others would argue that our quality workforce does the job right the first time, with less overall people on the project. There are critics out there that have always thrown the less productive dart at St. Louis, stating they can build 2 hours east or west for 20% less than in St. Louis. Where is

St. Louis, stating they can build 2 hours east or west for 20% less than in St. Louis. Where is the truth, who wants to admit it?? I know people who have lived their entire life in St. Louis who are claiming St. Louis is a dead city and looking for any opportunity to bolt.

Bottom line, we need to be aware of these perceptions and be willing to meet the challenges head on. I have seen work in other states that I would be very leery of entering the building after it was completed. I know the quality of our workforce; we need to promote a harmonious construction environment to anyone looking at St. Louis as possible location for their company. What that will take is a concerted effort from all as our civic leaders continue to try to convince business to come to St. Louis. They will need the assurances from the GC's and subcontractors who perform the work on these projects that the expectations can be surpassed before they even sit down to the table.

# **Managing Risk**

At all times, but especially in today's construction environment, it is vitally important to be able to assess and manage risk.

In the construction arena there are numerous pitfalls that can impact the success of a project. One of the more dangerous situations involves incomplete or poor design documents, plans, etc. You must be certain to resolve all ambiguities prior to bidding and /or provide for a contingency fund within your bid.

Another potential problem is scheduling. Time related costs can be fatal to a project whether due to unexpected delays or accelerated schedules. Be certain that you can live within the time frames established by the bid documents. Although delays usually cannot be predicted, be aware that any delays increase overhead and production suffers. In the event of any such disruptions in the project, be very thorough in documenting all the facts to support requests for time extensions and/or claims for delay damages.

Contract language is a growing problem in the construction field as owners and, in turn, general contractors seek to push the risk and liability downstream. There are numerous one-sided contracts being used to release parties from wrongful acts and negligence. Many contracts are beginning to assess "actual damages" rather than specified "liquidated damages", and these can become astronomical. It is imperative to have your attorney review all contract documents and don't hesitate to walk away from the extremely onerous contracts.

In the current environment when contractors are going further afield to find work, geographic risks increase. The lack of extensive knowledge of owners, generals, subs, suppliers, etc. can be problematic when working in an unfamiliar area of the country. Unfamiliarity with the work environment, union vs. open shop issues and the availability of skilled workmen can be further challenges. Extremely thorough investigations and perhaps partnering with a local contractor can help minimize such risks.

A related type of risk is the temptation to venture into a new type of construction work, beyond the prior

experience of a contractor and involving a different scope of work. This is a path that can lead to disaster if not approached carefully and conservatively until expertise is gained.

In a tight bidding market, such as we are experiencing these days, the temptation to cut margins in order to secure work is a recipe for disaster. Relying on buying out a job well or improving margins by relying upon future change orders are precarious approaches. As long as there is a continuing flow of work a contractor may be able to "steal" from one job to fund another, however, as the work dries up, so do the repositories of money and the profits.

Another area of risk which is difficult for contractors to address is the ability to reduce overhead in a timely fashion when volume is declining. With the majority of construction firms being family-owned businesses, this becomes an extremely difficult task when forced to make cuts that will necessarily involve family members in order for the business to survive.

Once a risk is undertaken, a contractor needs to be aware of the methods of resolving disputes or claims, should they arise. The various methods involved are litigation, arbitration, mediation and negotiation. Each of these options carries its own idiosyncrasies and a contractor needs to be aware of the advantages and disadvantages of each system of resolution.

The main approach to managing risk is always with the pre-bid preparation, i.e., identifying sources of risk, reviewing contract documents, seeking ways to mitigate potential hazards and being extremely diligent in all phases of bidding and job execution.

Finally, the key to successful risk management lies in creating a culture within a construction company that focuses on methods to identify, classify, analyze and then respond to risk. It is a philosophy that should be pervasive throughout the company and exist throughout the cycle of a project, not just after a problem occurs, and requires a systematic approach.

The diversity of projects include healthcare, primary and secondary education, financial institutions, colleges and universities, distribution facilities with a focus on alcohol and beer, tenant space revitalization and corporate re-location, government and sporting facilities. Although, the focus has been in St. Louis, in the very near future, expansion of the sales operations will include the Midwest and Southeast portions of the U.S.

Cabinet Masters is a member of the AWI (American Woodwork Institute) and complies with one of the organizations toughest standards, the Quality Certification Program otherwise known as OCP. This type of manufacturing requires a millwork company to meet the highest standards and tightest tolerances for the casework industry. Each and every project requiring the OCP must have documentation stating the manufacturing process, methods, materials and tolerances and on-site personnel will confirm the paperwork.

The month of August was very eventful on the political front! month decided several controversial races, Speaker Steve Tilley resigned and the race for U.S Senator got very controversial toward the end of August. September will be busy with campaigns continuing and the annual veto session where there is discussion that the General Assembly will attempt to override the Governor's veto of a few bills.

The primary election was held on Tuesday, August 7. After a low voter turnout, the fate of several candidates in many controversial races was decided. Here is a quick recap of the primary winners: Incumbent Senator David Pearce (R) defeated challenger Mike McGhee (R); former Representative Ed Emery (R) and Representative Scott Largent (R) fought for this open seat with Emery winning; former Representative Mike Cunningham (R) defeated House colleagues Don Wells and Ward Franz (R); overwhelmingly, Representative Wayne Wallingford (R) beat colleague Ellen Brandon (R); Representative Jason Holsman (D) defeated Jackson County Legislator Crystal Williams (D); Representative Jamilah Nasheed (D) defeated Incumbent Senator Robin Wright-Jones (D) and House colleague Jeanette Mott-Oxford (D). These winners do not have a primary and will take office in January. One other controversial and notable primary win was incumbent Lt. Governor Peter Kinder defeated State Senator Brad Lager. Kinder's final fate will be decided in November when he takes on Democrat Susan Montee in November for the Lt. Governor seat.

Just one week after the primary election Speaker Steve Tilley resigned. Tilley was term limited and could not run for another term in the House. As you may recall, he ended his bid for Lt. Governor last fall, citing his recent divorce and wanting to spend more time with this family. Those same reasons prompted his early resignation. Tilley's term would have ended the first of January when the legislature resumed. Speaker Pro Tem Shane Schoeller will fill his shoes until Speaker-elect Tim Jones is officially voted in as speaker which could be as early as veto session.

Many were surprised on August 7, when U.S. The primary election early in the Representative Todd Akin, won the Republican primary and was chose by Missouri voters to run in the November general election against Democrat incumbent, U.S. Senator Claire McCaskill. primary win was less shocking than the comments he made shortly after his primary win while being interviewed on a local St. Louis news program. Comments Akin made regarding rape and abortion outraged people nationwide, earned several days of media attention and caused the leaders of the Republican party across the nation to pull their support from Akin begging him to step down. Akin refused to cave to the immense pressure he received, stating the people of the State of Missouri spoke clearly of their support of him when they elected him and he would not step down. There is still time for Akin to get out of the race and allow the Republicans to appoint someone to succeed him; however that time is narrowing. As of press time Akin is still refusing to step down. The greater significance of this race was that the Republican party saw Missouri as one of the best opportunities to take out an incumbent Democrat Senator which would move the Republicans one step closer to having a majority in the U.S. Senate. It now looks less likely this will happen. This will be an interesting race to watch between now and November.

> Finally, the General Assembly's annual veto session will be held on September 12. There are a few vetoed bills the Republican lead majority will likely attempt to override. While the Senate must have a simple majority to override a veto of the Governor, the House needs 109 votes to override a Governor's veto. With the early departure of Speaker Tilley, the House has 105 Republican members, it would need to retain all the Republicans and convince at least 4 Democrats to vote with them to override a veto. As you may recall, the House was able to garner enough votes to override the Governor's veto of the redistricting bill last year. Nikki Strong.

# ASA's National Construction Best Practices Awards Not Just for General Contractors!

Is your firm among the many specialty trade contractors that are eligible to apply for ASA's National Construction Best Practices Awards?

In March 2012, ASA presented its first-ever National Construction Best Practices Awards to five construction contractors, including two specialty trade contracting firms. ASA grants the awards annually to recognize contractors that implement superior business practices such as safety management and prompt payment of subcontractors.

Any construction contractor, including a specialty trade contractor, that has signed a contract for construction services during the past year directly with a construction owner is eligible to apply for a National Construction Best Practices Award.

The application should include a completed application form, properly signed and sealed recommendations from three of the applicant's subcontractors, a copy of the applicant's standard subcontract agreement, and the \$495 application fee.

# Applications are due Nov. 16, 2012.

ASA will announce award recipients in January 2013 and present the awards at a ceremony in conjunction with the ASA Business Forum and Convention 2013 in Las Vegas, Nev., March 21-23.

# **Confined Space Entry Safety, are you Prepared?**

Confined space entry is one of the leading causes of occupational fatalities in this country right behind fall related fatalities. The standard covers 240,000 workplaces and 12.2 million workers. Workers make 4.8 million entries/ year and it is felt that this standard alone may prevent 85% of fatalities and nearly 11,000 injuries.

## So what is the definition of a confined space?

- Limited means of egress
- Can be bodily entered
- Not designed for continuous occupancy

#### What is the definition of a permit required confined space?

- Contains or has potential to contain a hazardous atmosphere
- Contains the potential for engulfment (this means lungs filled with water, grain, dirt, etc.)
- Internal configuration that can trap or asphyxiate entrant
- Any other serious safety or health hazards

<u>Typical permit confined spaces</u> can be Chemical storage tanks, Waste or storage pits, Grain bins, underground tunnels, sewers, just to name a few.

<u>Typical non permit required confined spaces</u> can be Utility closets, Below-grade trenches, Storage vaults, Utility subbasements

There are a number of potential confined space hazards. They include Engulfment, Oxygen deficiency (19.5% or less), Oxygen enrichment (23.5% or higher), Flammable gases or vapors, Combustible dusts, Toxic substances, IDLH atmospheres, or other physical hazards.

Before entry into a known permit required confined space or entry into a confined space that has not been previously classified as a non-permit required confined space, atmospheric testing for hazards must be tested for in this order:

- 1. Oxygen content
- 2. Combustibility/flammability
- 3. Toxic atmospheres.

This is usually done with a multi-function atmospheric testing device that is readily available from safety supply stores. The hazard must then be reduced to acceptable safe limits.

## So what are your responsibilities as an employer?

- Formulate and manage the confined spaces program. This
  includes a written confined space entry plan made readily
  available for employees to view.
- Maintain a space inventory of known confined spaces
- Maintain a list of "Authorized Personnel"
- Maintain copies of space permits
- Direct the confined space training program which includes formal documented training for all entrants, attendants, and supervisory personnel.
- Maintain rescue equipment if you choose to perform your own rescues.
- Coordinate any subcontractor activities who are working for you.

There is by far too much to write about confined spaces that the size of this article will permit. What I have outlined so far are a few of the definitions and responsibilities about confined spaces that are part of a much more detailed confined space entry class that I teach to companies and their employees. My main goal of this limited venue is to get "you the employer" thinking about your own situation.

- Do you encounter confined spaces?
- Do you have any type of confined space entry program?
- Are you testing regularly for hazards?
- Are you confident that all your employees are trained and that you have documented it?
- This is an important subject and it needs your immediate attention if you are unsure about any aspect of confined space safety.
